- **First time applicants are required to include a non-returnable photo of your craft (s).** This is a juried show open only to exhibitors who make handcrafted items.
- Electrical outlets are available for \$5 each. Crafters must provide their own heavy duty cords.
- Each crafter is individually responsible for satisfying any tax or licensing requirements.
- Food and drinks sponsored by the OBPA will be available in the cafeteria.
- **REFUND POLICY:** 100% refund up to November 2, 2017. After November 2, there will be **NO REFUNDS OF ANY FEES**.
